4. FIRST AID MEASURES

4.1 Description of first aid measures

General information

Symptoms of poisoning may even occur after several hours; therefore, medical observation for at least 48 hours after the accident.

Immediately remove any clothing soiled by the product.

After inhalation: Supply fresh air; consult doctor in case of complaints.

After skin contact

Immediately rinse with water.

After eye contact

Remove contact lenses if worn.

Rinse opened eye for several minutes under running water. If symptoms persist, consult a doctor.

After swallowing

Rinse out mouth and then drink plenty of water.

Do not induce vomiting; call for medical help immediately.

Gastric or intestinal disorders.

If blue coloring appears (lips, ear-lobes, finger-nails), give oxygen treatment as quickly as possible.

Monitor circulation, possible shock treatment.

Medical supervision for at least 48 hours.
